SUFFIX	Always “ØØ” for facility records, or sequentially ascending suffix beginning at “FØ” for prescriber or location records
NAME	Legal /DBA name of the facility, prescriber or location
ADDRESS1	First address line
ADDRESS2	Second address line
CITY	City
STATE	State, province or region
ZIP	Postal Code
COUNTRY	ISO 3166 country code
TELEPHONE	Telephone number of the facility, including area code or country/city code for foreign entities. Field is left justified, no delimiters.
CLASS OF TRADE	Class of trade code, corresponds to “market segments” for facilities, “activity codes” for locations, “program codes” for PHS covered entities and “credentials” for prescribers. See code lists below.
DEA	DEA number
DATE HIN ASSIGNED	The date on which the HIN was first assigned (yyyymmdd). If you receive the file in comma-delimited format, the date follows American format (mm/dd/yy).
DATE LAST EDITED	The date on which any information in the record was last modified (yyyymmdd). If you receive the file in comma-delimited format, the date follows American format (mm/dd/yy).
STATUS	AC = active DE = deactivated (or inactive)
